

## **QUALITY POLICY FOR THE INFORMATION AND VISITOR HOSPITALITY SERVICE OF THE CHIPIONA CITY MUNICIPAL TOURIST OFFICE**

Chipiona City Council's Municipal Tourist Office has the infrastructure and services needed to provide an excellent tourist information and visitor hospitality service, which is in line with the requirements and needs of the tourist that visits our city.

This tourist office is constantly working to maintain and improve the services offered to the tourist/visitor. Therefore, great importance is given to the suggestions made by the users and the satisfaction surveys handed in to our office in order to cover the needs of the tourist or visitor, with a special emphasis on improving the quality of said service.

The following services are provided by the office:

- ✦ Tourist assistance in the following forms:
  - *In person*: directly and immediately dealing with the requests of the visitor or tourist in the tourist office, along with providing printed tourist material. This service is offered in different languages.
  - *Distance*: dealing with the requests of the tourists remotely, whether by telephone, email or post. This service is offered in different languages.
  - *Customized*: providing a customized assistance service, when dealing with a collective or group that requires it due to their characteristics. This service is offered in different languages.
- ✦ Guided visits for associations and non-profit entities.
- ✦ The services provided will be free of charge except: Visit to the lighthouse (5 €), visit to the Interpretation Center "Cadiz and the New World" (2 €)
